Dear Mr. Abramo:

Your letter of July 20, 1973, to the New Jersey Election Law Enforcement Commission ("the Commission"), including a request for advisory opinion, has been forwarded to me for reply. By previous correspondence, the Commission requested an extension of time within which to reply to August 20, 1973.

- (a) Where 60-day interval reports are required, such reports must be filed at the conclusion of each 60-day interval from the first filing date on July 24, 1973.
 - (b) As to candidates or political committees whose obligation to file is limited to the filing of 60-day interval reports (e.g., a political committee of a candidate defeated in the primary election), the filing date for such reports is September 22, 1973.
- (c) As to candidates and political committees having an obligation to file the 25 day pre-election report as well as the 60-day interval report, and as to political party committees, the filing date is October 12, 1973. The Commission will regard a report filed on October 12, 1973 as satisfying both the 60-day interval report requirement and the 25 day pre-election report requirement, provided the report includes all contributions received and expenditures made from July 23, 1973 to October 11, 1973.

2. Forms promulgated for filing on July 24, 1973 should not be used for subsequent reports. Forms for the required reports will be provided by the Commission as soon as possible.

We are in receipt of the form of Report of Receipts and Disbursements for a Candidate in the New Jersey Primary Election held on June 5, 1973, together with the accompanying Instructions which, I note, "apply only to the New Jersey Primary Election held on June 5, 1973."

The aforesaid Instructions make no reference to successive subsequent filings pursuant to Section 16 of the above-described law; viz:

"Until such certification (of dissolution) has been filed, each such treasurer shall continue to file, at the conclusion of each 60-day interval from the fifteenth day following such election, reports in the form and manner herein prescribed."

Please advise whether such successive reports must be filed at the conclusion of each 60-day interval from the fifteenth day following the election held on June 5, 1973 or at the conclusion of each 60-day interval from the first filing date on July 24, 1973.
