I am writing on behalf of the Essex County Republican Committee for an advisory opinion in accordance with the New Jersey Campaign Contributions and Expenditures Reporting Act.

- (1) Is it proper for the Committee to maintain two banking accounts, one for the year-round operation of our Committee (Headquarters Account rent, insurance, telephone, secretarial assistance, accounting services, etc.), and a second account, Campaign Account, for the 1973 general election?
- (2) If the Headquarters Account can be maintained, and the Committee requires two signatures on each check, may the County Chairman be an authorized signatory together with the Committee's Treasurer or Assistant Treasurer?
- (3) If these two accounts are proper, can some funds raised for the Headquarters Account be transferred to the Campaign Account?
- (4) If these two accounts are proper, can non-spent Campaign funds be transferred to the Headquarters Account?
- (5) May individual candidates, through their Campaign Accounts, make contributions to the Committee's Headquarters Account?
