July 18, 2017

The meeting convened at 11:00 a.m. in Trenton.

1. Open Public Meetings Statement

Chairman DeFilippis called the meeting to order. Executive Director Brindle announced that pursuant to the "Open Public Meetings Act," <u>N.J.S.A.</u> 10:4-6 <u>et seq</u>., adequate notice of the meeting of the Commission had been filed with the Secretary of State's Office and distributed to the entire State House Press Corps.

On a motion by Commissioner Jaso, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission selected William Paterson/CBS/Record/Gannett to sponsor a gubernatorial general election debate.

On a motion by Commissioner Simon, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission selected NJ Performing Arts Center/ABC/Univision/Rutgers/League of Women Voters/NALEO to sponsor a gubernatorial general election debate.

On a motion by Commissioner Jaso, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission selected Montclair State University/NJTV to sponsor the lieutenant gubernatorial debate.

Chairman DeFilippis thanked the sponsors and stated that all the presentations were outstanding and phenomenal. The Chairman communicated to those that didn't get included to talk to those that were selected and see if they can partner up with them.

3. Approval of Public Session Minutes of June 20, 2017

On a motion by Commissioner Holden, seconded by Commissioner Jaso, and passed by a vote of 3-0, the Commission approved the Public Session Minutes of June 20, 2017. Commissioner Simon abstained from the vote.

4. <u>Executive Director's Report</u>

Executive Director Brindle welcomed Commissioner Marguerite Simon to the Commission. The Executive Director presented the Executive Director's Report.

5. <u>Report on 2017 Gubernatorial Public Financing Program</u>

Compliance Director Olivo presented the gubernatorial public financing report.

6. <u>Adoption of "Sunset" Proposal</u>

Assistant Legal Counsel Scott Miccio presented the re-adoption of <u>N.J.A.C</u>. 19:25 and provided a summary for the adoption of the "Sunset" proposal. The proposal was published in the <u>New Jersey</u> <u>Register</u>, 49 <u>N.J.R</u>. 1014(a) (May 1, 2017) and is also found on the Commission's website. Filing of the proposal notice extended the expiration of Commission regulations to September 21, 2017. No written comments were received by the June 30, 2017 deadline for receipt of written comments.

On a motion by Commissioner Jaso, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission re-adopted the regulations at <u>N.J.A.C</u>. 19:25 and directed staff to file the notice of adoption with the Office of Administrative Law.

7. <u>Public Comments</u>

At this juncture, Assistant Legal Counsel Miccio left the meeting and there were no public comments.

8. <u>Resolution Authorizing an Executive Session</u>

Whereas, there exists a need to hold an Executive Session for the purpose of discussing the following matter/matters, which fall within the exceptions to the Open Public Meetings Act, <u>N.J.S.A.</u> 10:4-12 *et seq.* to wit.

Whereas, it is unknown at this time when such discussion to take place in Executive Session may be disclosed to the public.

Now Therefore Be It Resolved by the Election Law Enforcement Commission as follows:

- 1. This Executive Session Meeting of the Election Law Enforcement Commission shall be closed to the public for discussion of the aforesaid referenced matters.
- 2. The matters discussed during this Executive Session Meeting shall be disclosed to the public at such time when reason for discussing and acting on same in Executive Session shall no longer exist.

On a motion by Commissioner Holden, seconded by Commissioner Jaso, and passed by a vote of 4-0, the Commission resolved to enter Executive Session to discuss anticipated litigation and current litigation, which will become public as follows:

- A. Final Decision Recommendations in complaint proceedings, which will not become public. However, the Final Decisions resulting from those recommendations will become public not later than seven business days after mailing to the named respondents.
- B. Matters under current litigation, the substance of discussions of which will not become public in order to protect the attorney-client privilege and the deliberative process. However, any litigation in which the Commission is currently a party is a public matter and will become public subject to the above limitations and privileges.

9. <u>Final Decision Recommendations</u>

On a motion by Commissioner Simon, seconded by Commissioner Jaso, and passed by a vote of 4-0, the Commission approved the Final Decision Recommendations, items 1, and 3 thru 26, as recommended by staff.

On a motion by Commissioner Simon, seconded by Commissioner Jaso, and passed by a vote of 3-0, the Commission approved the Final Decision Recommendation, item 2, as recommended by staff. Commissioner Holden recused himself from this vote.

10. Executive Session Memorandum: Final Decision Recommendation

On a motion by Commissioner Jaso, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission approved the Final Decision Recommendation, item 1, as presented by staff.

11. Office of Administrative Law (OAL) - Initial Decision

On a motion by Commissioner Jaso, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission adopted the Initial Decision of the OAL.

12. <u>Public Comments</u>

No public comments. Meeting adjourned.

13. Adjournment

On a motion by Commissioner Jaso, seconded by Commissioner Holden, and passed by a vote of 4-0, the Commission resolved to adjourn at 3:20 p.m.
