Frederick M. Herrmann, the Executive Director of the Election Law Enforcement Commission announced today that the Commission at its public meeting Wednesday, May 29, 1985, certified \$160,567.02 in public matching funds to gubernatorial primary election candidates as follows:

The amounts certified include partial certification for applications made on Tuesday, May 28, 1985.

To date, the Commission has certified a total of \$416,939.42 in public matching funds to former U. S. Attorney Del Tufo (D), \$577,619.46 in public matching funds to Newark Mayor Gibson (D), \$643,572.40, the maximum, in public matching funds to Governor Kean (R), \$643,572.40, the maximum, in public matching funds to State Senator Russo (D), \$643,572.40, the maximum, in public matching funds to Essex County Executive Peter Shapiro (D), and \$628,762.33 in public matching funds to former State Senator Wiley (D). Including Wednesday's certification, the Commission has certified a total of \$3,554,038.41 as follows:

The Commission has transmitted the certifications to the State Treasurer who, it is anticipated, will issue checks later this week. The checks will be deposited by the Commission in the candidates' public funds bank accounts and will be available for use immediately thereafter.

On Tuesday, the Commission received applications for public matching funds from three candidates. The Commission received applications for the current submission period from Mr. Del Tufo, Mayor Gibson, and Mr. Wiley. The candidates reported contributions (less refunds) for this submission period as follows:

Tuesday marked the fifteenth date on which candidates could make application for public matching funds. To date a combined total of \$2,213,300.18 in contributions raised (less refunds) has been indicated by candidates making application for public matching funds.

The New Jersey public financing program provides that each dollar of a contribution be matched with two dollars of public funds after a candidate has raised and spent a minimum of \$50,000.00 in contributions of \$800.00 or less. The maximum amount that a qualified candidate can receive in public matching funds for the 1985 gubernatorial primary is \$643,572.40.

The submissions received Tuesday will be reviewed and the Commission will certify to the State Treasurer an amount each candidate is eligible to receive for the fifteenth submission period at its meeting on Monday, June 3, 1985.
