Frederick M. Herrmann, Executive Director of the Election Law Enforcement Commission, announced today that the Commission released a list of names of candidates in the run-off election who have not filed any required disclosure reports with the Commission as of noon yesterday, June 11, 1985. The list contains 5 candidates for local municipal office.

These candidates were required to file a detailed campaign report 11 days prior to the election (May 31), or a Sworn Statement indicating that expenditures on their behalf would not exceed \$2,000. This form was required to be filed on or before the 11th day prior to the election (May 31, 1985).

Timely filing may be accomplished by submitting an original and two copies of the report to the county clerk's office before noon on the filing date. After that time, filing is only accomplished by submitting the reports directly to the Commission's office in Trenton. Reports filed at the county clerk's office after noon will not be considered filed until such time that they arrive at the Commission's office in Trenton.

The publication of this list is part of revised Commission procedures, begun with the 1978 primary election, designed to foster compliance, enhance disclosure, and make enforcement more effective.

The candidates whose names appear on the attached list will be the subject of Commission complaints and hearings for non-filing unless there are extraordinary mitigating circumstances responsible for the failure to file. They will be subject to possible fines of up to \$1,000 if found in violation. Additionally, the candidates will be required to file the appropriate reports or Candidate-Sworn Statements.

Other candidates in the 1985 run-off election who have already filed, but filed late, or have substantive problems in their reports, also will be subject to possible reprimand or fines through the Commission hearing and complaint process.
