#### PRESS RELEASE

According to figures released today by the New Jersey Election Law Enforcement Commission (ELEC), the 1991 General election proved to be the most expensive legislative election in State history.

"Spending in 1991 has increased by 34 percent since 1987, the last time both the Senate and General Assembly were up for election," said Frederick M. Herrmann, Executive Director of ELEC. In 1987, legislative candidates spent \$11,268,193 compared to \$15,080,195 spent in 1991.

"These figures," Herrmann said, "dramatically point to the need for reform in the campaign financing laws by enacting contribution limits, which will place some measure of control over the proliferating financial activity by candidates." Herrmann stated further that, "contribution limits will guarantee the public that a candidate may not receive excessive amounts of funds from a single source. Such activity leads to voter disenchantment with the electoral process."

The continuing dramatic increase in legislative spending despite the recession further accentuates ELEC's need for adequate funding. Notwithstanding the fact that spending continues to rise at a burgeoning rate, ELEC's full-time staff has actually declined by a third over recent years. The Commission has suggested that the special interests ELEC regulates, not the taxpayers, support its work through the implementation of filing fees.

"Campaign spending has nearly tripled since 1983, going from \$5.5 million to over \$15 million this year." said Herrmann.

Democrats spent over three-and-a-half million dollars more than Republicans in 1991, \$9,264,911 to the Republicans \$5,664,288. Independents, meanwhile, spent only \$150,996.

Incumbents outspend challengers by almost two-and-a-half million dollars, \$8,785,430 to \$6,294,765. Winners and losers were differentiated by a million dollars in their spending totals. Winners spent \$8,055,079 in 1991 and losers spent \$7,025,116.

Overall fundraising by legislative candidates saw a 10 percent increase, going from \$15,071,611 in 1987 to \$16,558,696 in 1991.

This press release is a compilation of figures reported to the Commission on statistical information sheets submitted as part of the 20-day postelection report. The data is in rough format and may be subject to change after the reports are more fully reviewed. It should be noted that the Commission has the ability to arrange the data in various other formats upon request.

Only those statistical information sheets submitted by 5:00 p.m. on December 9, 1991, are a part of this release. If a candidate or treasurer failed to submit a statistical information sheet, the staff of ELEC used the report filed by 5:00 p.m. on December 9th to determine financial activity.

Although the Commission has taken all reasonable precautions to prevent mathematical or typographical errors, the possibility that some exist cannot be entirely eliminated. Copies of any report on file with the Commission are available for inspection during regular office hours.

Also, please be reminded that candidates and committees may transfer funds among each other. Although these transfers are counted in ELEC's statistics as receipts and expenditures, they are not transactions which create new funds. Nevertheless, ELEC's figures create a useful indicator of overall fundraising and spending in the 1991 General Election.
